Message from the CEO & President and Board of Trustees Chair



We are continually inspired by the generosity of our Catholic community and the unwavering dedication and passion of our staff and Board of Trustees. Here is a summary of the remarkable impact made in 2024 to solidify the future of our Church.

Stewardship and Impact

- We worked with over 750 parishioners throughout the Archdiocese and Deacon Steve along with Deacon Tim Kenny, preached at 15 parishes for a total of 65 Masses.
- The Foundation continued to grow with new Donor-Advised Funds, gifts of real estate (record high in one year), charitable gift annuities (CGA), and we added new Holy Family Legacy Society members.

Charitable Giving

- Over 1,300 grants were issued totaling \$28.7 million, hitting another all-time record high, up over \$9 million from the prior year. We have now surpassed over \$235 million in total grants issued since inception.
- Incoming current gifts exceeded \$30 million, a record high.

Investment Returns

The investment portfolio grew 11.6% in 2024.
 That's five of the past six years with double-digit growth (the exception being 2022).

People

- In 2024, our team underwent significant changes. We bid farewell to two of our tenured employees who retired: Denise McCarthy and Mary McAtee.
- Joshua Gideon pursued a new opportunity with The Knights of Columbus.
- Guided by the Holy Spirit, we welcomed several wonderful new members: Christine M. Hoyer, Jeff Wilson, Katie McGinty, and Deacon Tim Kenny, who filled a new position focused on the mountains. Our team is thriving, and we feel incredibly blessed.





Each year, The Catholic Foundation Board of Trustees allocates \$200,000 from the unrestricted fund to provide Teacher Salary Assistance for 20 Catholic schools within the Archdiocese of Denver. This initiative is specifically aimed at supporting schools that are in the greatest need, ensuring that they can continue to offer quality education despite challenges.

This annual commitment underscores
The Foundation's dedication to fostering
educational excellence and stability within the
Archdiocese, recognizing the vital role that teachers
play in shaping the future of their students. Through this
support, The Foundation not only aids in retaining talented
educators but also contributes to the overall educational
environment in these schools.

Investment Funds

One of the main purposes of The Catholic Foundation is to invest funds morally and responsibly to help support the future of our Church. The Catholic Foundation currently has a variety of funds: including over 200 donor-advised funds, along with endowments and parish funds.



Members of the Holy Family Legacy Society are parishioners who have generously included the Church in their wills or trusts as a beneficiary designation. Each year, we honor these members and our donor-advised fund holders with a special Mass celebrated by the Archbishop, followed by a dinner and fellowship to express our heartfelt gratitude for their unwavering dedication. The Catholic Foundation team also prays for current and deceased members each day during daily prayer. An annual Mass celebrated by the Archbishop is held each year for any intentions from this society.
